



RELEASE AND HOLD HARMLESS

With the signing of this Agreement I, the following individual and the parent or legal guardians thereof if a minor, do hereby agree to hire Team Rider Equine LLC to provide horse, tack, equipment and/or staff for the purpose of riding lessons.

Rider, and the parents or legal guardians if a minor, are subject to the terms of this Agreement. Rider represents that all information provided to Team Rider Equine LLC is accurate, and that he/she does not have any physical and/or mental health conditions, problems, and /or disabilities which may affect his/her safety and ability to ride a horse.

Rider understands horseback riding includes numerous obvious and non-obvious risks always present despite safety precautions. Related injuries can be severe. Rider understands no horse is completely safe. If a horse is frightened or provoked it may divert from its training and revert to its natural survival instincts, which are not limited to, but may include: biting, kicking, running from danger, stopping short, rearing, bucking, or changing directions at an instant.

Rider understands upon taking control of a horse, mounted or not mounted, that Rider is in primary control of the horse. Safety largely depends on Rider's ability to carry out directions and ability to stay balanced while on the horse. Rider agrees he/she is responsible for his/her own safety.

Rider understands Team Rider Equine LLC is not responsible for occurrences or elements of nature, such as wind, rain, water, thunder, lightning, other animals, insects, or reptiles which can spook a horse and cause it to react in an unsafe manner.

Rider understands wearing protective headgear while mounting, riding, dismounting and otherwise being around horses may prevent or reduce severity of some head injuries, and may prevent death happening as the result of a fall or other occurrence. Team Rider Equine LLC asks all riders to wear a riding helmet.

In consideration of Team Rider Equine LLC allowing Rider to participate in this activity, under the terms set forth herein, Rider and the parent or legal guardian if Rider is a minor or legal ward, do agree to hold harmless and release Team Rider Equine LLC from any loss, damage or legal liability from injury of any nature that may be a result of the action or inaction of Team Rider Equine LLC. I further agree I shall bring no claims, demands, actions and causes of action and/or litigation, against Team Rider Equine LLC for any economic and non-economic losses due to property damage, bodily injury, or death sustained by me and/or my minor child or legal ward during activities at or with Team Rider Equine LLC, to include riding, handling or otherwise being near horses.

Rider acknowledges the inherent risks associated with equine activities, and is willing and able to accept full responsibility for his/her own safety and welfare and releases Team Rider Equine LLC, and any other equine owner or agent, from liability unless Team Rider Equine LLC, equine owner or agent is grossly negligent or commits willful, wanton or intentional acts or omissions. Rider also acknowledges Rider executes this Agreement on behalf of Rider, as well as all of Rider's children, family members and guests.

This release shall apply to all activities conducted by Team Rider Equine LLC and/or on the Leased Premises, including activities in the future. It is not necessary for Team Rider Equine LLC to obtain a similar release for each time Rider visits or takes lessons.

I HAVE READ AND DO UNDERSTAND THE TERMS WITHIN THIS AGREEMENT, WARNINGS, RELEASE AND ASSUMPTION OF RISK.

Rider's Ability and Competency Levels:

Beginner: A rider who has limited experience and does not feel comfortable riding faster than a walk for any distance.

Intermediate: A rider who is confident and in control at all paces including lope/canter/gallop, and who rides regularly.

Advanced: A rider who is confident and in control of all paces including lope/canter/gallop is currently riding often and is capable of handling a spirited horse in open country.
